# Vaporizadores, cigarros eletrônicos e outros sistemas eletrônicos de entrega de nicotina (ENDS)

Vapes, vaporizadores, canetas vaporizadores, canetas narguilé, cigarros eletrônicos (e-cigarros ou e-cigs) e e-cachimbos são alguns dos muitos termos usados para descrever os sistemas eletrônicos de entrega de nicotina (ENDS). ENDS são produtos de tabaco **não combustíveis**.

Esses produtos usam um "e-líquido" que pode conter nicotina, bem como composições variadas de aromas, propilenoglicol, glicerina vegetal e outros ingredientes. O líquido é aquecido para criar um aerossol que o usuário inala.

ENDS podem ser fabricados para se parecerem com cigarros, charutos ou cachimbos convencionais. Alguns se parecem com canetas ou unidades flash USB. Dispositivos maiores, como sistemas de tanque ou mods, têm pouca ou nenhuma semelhança com cigarros.

#### Doenças respiratórias associadas ao uso de produtos de vaporização

Tanto a Food and Drug Administration quanto os Centros para Controle e Prevenção de Doenças dos EUA estão trabalhando incansavelmente para investigar os incidentes angustiantes de doenças respiratórias graves associadas ao uso de produtos de vaporização.

## Estatísticas sobre o uso de cigarros eletrônicos entre jovens dos EUA

- Entre os alunos do ensino fundamental e médio, 3,6 milhões eram usuários atuais de cigarros eletrônicos em 2020 (/tobaccoproducts/youth-and-tobacco/youth-tobacco-use-results-national-youth-tobacco-survey).<sup>1</sup>
- Mais de 8 em cada 10 jovens usuários atuais de cigarros eletrônicos usam cigarros eletrônicos com sabor, com os sabores de frutas, menta, doces e mentol entre os mais comumente usados.<sup>1</sup>
- De acordo com uma pesquisa de 2013-2014, 81 por cento dos jovens usuários de cigarros eletrônicos citaram a disponibilidade de sabores atraentes como a principal razão para o uso.<sup>2</sup>





# Regulamentação da FDA para Sistemas Eletrônicos de Entrega de Nicotina

Em 2016, o FDA finalizou uma regra estendendo a autoridade regulatória do CTP para cobrir todos os produtos de tabaco (/tobaccoproducts/rules-regulations-and-guidance/fdas-deeming-regulations-e-cigarettes-cigars-and-all-other-tobacco-products), incluindo sistemas eletrônicos de entrega de nicotina (ENDS) que atendem à definição de produto de tabaco. A FDA regula a fabricação, importação, embalagem, rotulagem, publicidade, promoção, venda e distribuição de ENDS, incluindo componentes e peças de ENDS, mas excluindo acessórios. Exemplos de componentes e partes do ENDS incluem:

- E-líquidos
- Um frasco de vidro ou plástico com e-líquido
- Cartuchos
- Atomizadores
- Certas baterias
- · Cartomizadores e claromizadores
- Display digital ou luzes para ajustar as configurações
- Sistemas de tanque
- Dicas de gotejamento
- Aromas para ENDS
- Software programável

Products marketed for therapeutic purposes (for example, marketed as a product to help people quit smoking) are regulated by FDA Center for Drug Evaluation and Research (CDER). FDA published a rule clarifying when products made or derived from tobacco are regulated as tobacco products, drugs, and/ or devices (https://www.federalregister.gov/documents/2017/01/09/2016-31950/clarification-of-when-products-made-or-derived-from-tobacco-are-regulated-as-drugs-devices-or).

In January 2020, FDA issued an enforcement policy on unauthorized flavored cartridge-based e-cigarette products, including fruit and mint flavors, that appeal to kids. # **Manufacturing Electronic Nicotine Delivery Systems and E-Liquids**

If you make, modify, mix, manufacture, fabricate, assemble, process, label, repack, relabel, or import ENDS, you must comply with the requirements for manufacturers (/tobacco-products/compliance-enforcement-training/manufacturing).

CTP's Office of Small Business Assistance (/tobacco-products/compliance-enforcement-training/small-business-assistance-tobaccoproduct-industry) can answer specific questions about requirements of small businesses and how to comply with the law. This office also provides online educational resources to help regulated industry understand FDA regulations and policies. Beginning in 2018, all "covered" tobacco products\* must bear the required nicotine addictiveness warning statement (/tobaccoproducts/labeling-and-warning-statements-tobacco-products/covered-tobacco-products-and-roll-your-own-cigarette-tobacco-labelingand-warning-statement) on product packages and advertisements. \**Note*: Cigars (/tobacco-products/products-ingredientscomponents/cigars-cigarillos-little-filtered-cigars), which are also "covered" tobacco products, have additional required warning statements.

## **Retail Sales of Electronic Nicotine Delivery Systems and, E-Liquids**

**Note:** On December 20, 2019, the President signed legislation to amend the Federal Food, Drug, and Cosmetic Act, and raise the federal minimum age of sale of tobacco products from 18 to 21 years. It is now illegal for a retailer to sell any tobacco product – including cigarettes, cigars and e-cigarettes – to anyone under 21. FDA will provide additional details on this issue as they become available, and the information on this page will be updated accordingly in a timely manner.

If you sell ENDS, e-liquids, or their components or parts made or derived from tobacco, please read this summary of federal rules that retailers must follow (/tobacco-products/retail/summary-federal-rules-tobacco-retailers).

# Vape Shops That Mix E-Liquids or Modify Products

If you operate a vape shop that mixes or prepares liquid nicotine or nicotine-containing e-liquids, or creates or modifies any type of ENDS, you may be considered a manufacturer. As a result, some vape shops may have legal responsibilities as both manufacturers and retailers (/tobacco-products/compliance-enforcement-training/pipe-cigar-and-vape-shops-are-regulated-both-retailers-and-manufacturers) of tobacco products. ## **Importing Electronic Nicotine Delivery Systems and E-Liquids**

Tobacco products imported or offered for import (/tobacco-products/products-guidance-regulations/importing-and-exporting) into the United States must comply with all the applicable requirements under the Federal Food, Drug, and Cosmetic Act (FD&C Act).

# **Report a Problem with a Tobacco Product or Potential Tobacco Product Violations**

If you have experienced undesired health or quality problems with a specific tobacco product, you can report a problem (/tobaccoproducts/science-research/safety-reporting-portal-tobacco-products) with any tobacco product, including vapes, to the FDA. Knowledge about adverse experiences can help the FDA identify health or quality problems beyond those normally associated with tobacco product use.

If you believe these products are being sold to minors, or you see another potential violation of the FD&C Act or FDA's tobaccoregulations, report the potential violation (/tobacco-products/compliance-enforcement-training/report-potential-tobacco-productviolation).
